



**AWS DEEPRACER LEAGUE PRESENTED BY ACCENTURE CONTEST**  
**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO PARTICIPATE.**

**1. CONTEST PERIOD:** The AWS DeepRacer League Presented by Accenture ("Contest") begins on or about 1, March, 2020 at 12:00:01 AM (Midnight) Greenwich Mean Time ("GMT") and ends on or about 4, December, 2020 at 11:59:59 PM GMT ("Contest Period"). Please see [world clock](#) for time zone conversion information. During the Contest Period there will be thirty-seven (37) Summit Circuit Events, eight (8) Virtual Circuit Events, and one (1) Championship Event. Sponsor, at its sole discretion, may determine to replace certain Summit Circuit Events with virtual Summit Online Events races. Further details will be provided at [www.awsdeep racerleague.com](http://www.awsdeep racerleague.com) for all dates and event locations.

**2. ELIGIBILITY:** The Contest is open to those who meet the following eligibility requirements:

- i. Summit Circuit: You must be aged the greater of 18 or the age of majority in your jurisdiction of residence, or over, to participate.
- ii. Virtual Circuit or Summit Online Event Race: You must hold an AWS account, valid email address, and operate an Internet browser and be the minimum age listed below based on the country or region in which you are located (if the minimum age listed is below the age of majority in your jurisdiction of residence, you must have consent to participate from your parent or legal guardian):

- iii. The following are excluded from entering any part of the Contest:
  - 1. Employees of the Sponsor, Administrator, and their respective affiliates and subsidiaries or anyone professionally associated with this Contest. Employees of Accenture are eligible to participate in this Contest.
  - 2. Residents of countries that are on the USA banned trading lists: the Balkans, Belarus, Myanmar/Burma, the Ivory Coast, Cuba, the Democratic Republic of Congo, Iran, Iraq, Lebanon, Liberia, Libya, North Korea, Somalia, Sudan, Zimbabwe.
  - 3. Residents of the province of Quebec in Canada.
  - 4. Residents of the following provinces of Argentina: Mendoza, Córdoba, Neuquén and Tierra del Fuego.

5. Anyone subject to OFAC sanctions, including any individual on the OFAC SDN list and any individuals residing in Cuba, Iran, North Korea, Syria, or the Crimea Region of Ukraine.

Before racing, entrants that are under 18 years of age, or the age of majority in their jurisdiction of residence if above 18, must show these Official Rules to their parents or legal guardians and receive their permission to agree to these Official Rules, participate in the Contest, and submit their personal information to Sponsor. Where parental permission is required, entrants must be able to provide evidence that their parent or guardian has consented to their participation in the Contest, or if required, execute documentation that confirms this fact in a form reasonably acceptable to Sponsor.

Entrants must ensure that participation (and acceptance of any prize awarded) is lawful in accordance with the laws of the country or region in which they are a resident. Void where prohibited by law. All local laws and regulations apply. Participation constitutes entrant's full and unconditional agreement to these Official Rules. Interpretation of the Official Rules will be objective and based on principles in good faith and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator.

3. **HOW TO PARTICIPATE:** During the Contest Period, eligible entrants will have the opportunity to participate in Summit Events, Virtual Events, Summit Online Events, and potentially the Championship Event. There is no limit on the number of races that an entrant can enter, in person or virtually. An entrant can race in any combination of Summit Event races, Summit Online Event races, and Virtual Event races, and can race at multiple races in each Circuit.

**Summit Event Races:** To participate in an in-person Summit Event race, eligible entrants will be required to register at the applicable track with an AWS representative, including supplying applicable details (title, name, surname, display name, country/region, email, and phone number) and provide agreement to these Official Rules. Upon completing the foregoing steps, an eligible entrant's Reinforcement Learning model will then be loaded into a DeepRacer car, provided by Sponsor in its sole discretion. Entrants can either bring a USB stick with his/her own trained Reinforcement Learning model or can select an AWS DeepRacer Reinforcement Learning model from the 'model selector' at the Summit Event. Each Summit Event will include two (2) races: (i) a time trial race ("Time Trial"), and (ii) a head to head race ("Head to Head"). You will have four minutes to record your fastest valid lap time (as recorded by the by AWS employee). Your lap time will then be entered into the live race leader board along with your rank and display name. After the race the race results will be displayed (display name, rank, lap time, country) on the AWS DeepRacer League website. Eligible entrants may participate in both races. Additional details, including the Schedule and Standings, may be found at [www.awsdeepracerleague.com](http://www.awsdeepracerleague.com). There will be a total of five (5) winners per race, one (1) first prize winner and four (4) second prize winners, for a total of ten (10) winners per Summit Event. Winners will be determined as set forth in Section 4 below. Sponsor/Administrator cannot guarantee that all attendees at Summit Events will be able to participate in a race, and reserve the right to limit entry to one race only as may be determined by AWS representatives at Summit Events in their sole discretion. Sponsor/Administrator

accepts no liability if any attendee is unable to participate for reasons of over-capacity. However, if there is capacity you may race more than once and only your best time will be kept.

**Virtual Event Races:** To participate in an online Virtual Event race, eligible entrants must log into his/her AWS account and navigate to the AWS DeepRacer service in the AWS console. Entrants may then follow the links and instructions to provide agreement to these Official Rules and to submit his/her AWS DeepRacer Reinforcement Learning model into the applicable virtual race. Sponsor/Administrator accepts no liability if entrant's model fails to evaluate or submit for any reason. Each Virtual Event will include three (3) races: (i) a Time Trial race, (ii) an object avoidance race ("Object Avoidance"), and (iii) a Head to Head race. Your submitted model's performance will then be programmatically evaluated in the race according to the specified race setup. Your model will then be ranked based on a ranking metric, typically total time taken to complete the race, however, this metric may change on a per race basis and this change will be indicated in the race setup. You can submit multiple models to any given race, but only your best submission will be kept and ranked. After each race, the race results will be displayed on the AWS DeepRacer League website. Additional details, including the Schedule and Standings, may be found at [www.awsdeepracerleague.com](http://www.awsdeepracerleague.com). There will be a total of five (5) winners per race, one (1) first prize winner and four (4) second prize winners, for a total of fifteen (15) winners per Virtual Event. Winners will be determined as set forth in Section 4 below.

**Summit Online Event Race:** During the Contest Period, Sponsor may determine to move certain AWS Summits, where in-person Summit Event Races were scheduled, to virtual Summit Online Events. In such an event, eligible participants may participate in a Summit Online Event Race. Such races shall follow the same terms and conditions as outlined for Virtual Event Races in these Official Rules, with the following exceptions: (i) each Summit Online Event Race shall include a Time Trial race and a Head to Head race (e.g., there will be no Object Avoidance); and (ii) a varying number of first prizes and second prizes will be awarded per each Summit Online Event Race, allocated by the number of in-person AWS Summits replaced by a Summit Online Event. Additional rules and other details may be found at [www.awsdeepracerleague.com](http://www.awsdeepracerleague.com).

**Championship Event Race:** Selected first prize winners may have the opportunity to race in the Championship Event at re:Invent 2020 in Las Vegas, NV USA on 30 November 2020. Details of Championship event and winner determination will be available to qualifying entrants prior to participation and posted at [www.awsdeepracerleague.com](http://www.awsdeepracerleague.com). All entrants must read and agree to the Championship Event Race rules prior to participation.

All entries to the Summit Circuit, Virtual Circuit, Summit Online Event, or Championship Event race(s) must be received prior to closing of the applicable race to be valid. No liability is accepted by the Contest Entities for late entries. If you are a government or public sector employee, you certify that you have confirmed with appropriate parties that acceptance of the Prize Package complies with your internal policies and any applicable law and regulations

- 4. WINNER DETERMINATION:** The rules may vary per race and will be communicated at track side or online at <https://aws.amazon.com/deepracer/league/rules-and-prizes/>. At the race, there may be a board indicating whether any of the rules were adjusted for this particular race

and if so, they will supersede these rules.

**Summit Circuit Race Rules:**

- a. Your model must be trained with a single camera configuration to compete in Time Trial race format.
- b. Your model must be trained with at least stereo cameras “Evo” configuration to compete in Head-to-Head race format.
- c. You may only race with a stock AWS DeepRacer from the devices made available by AWS at the race. The device provided is at the sole discretion of the AWS DeepRacer Pit Boss, and substitutions will not be made. Each device has been tested and calibrated by our pit bosses to work within consistent mechanical and network condition, no unit has been identified as advantageous or suboptimal.
- d. All timings shall be as determined by an AWS employee using a stop-watch, timekeeping app, or other timing device, and all times are final.
- e. For head-to-head racing, two stationary objects will be placed in predetermined places along the track. The quantity and positioning of said objects shall remain consistent for all competitors.
- f. The objective of a head to head race is to successfully complete a lap faster than AWS Bot Car.
- g. Each race attempt will last for 3 minutes. During your attempt, you may restart your lap as often as you like, while the 3-minute (or other duration) race attempt timer is running. If your timer runs out in the middle of a lap that lap will not be counted. Once your timer has run-out your attempt is over. You can queue again for another race attempt, subject to availability and the track being open.
- h. For a lap to be valid, the car has to complete one lap around the entire track following the indicated direction of the track, starting when the front wheels of the car touch the starting line (when moving), or standing on the line (when starting from standstill), and touching the starting line again with the front wheels of the car. If your car was reset more than three times during a lap, the lap is not valid.
- i. During a reset, the lap timer will not be stopped, it will keep running. If you have more than three resets in a time trial lap, the lap will be marked as "did not finish" ("DNF") and the lap time will not be recorded. A lap is valid in time trial if completed lap with less than 3 resets.
- a. For Head-to-head race, only laps where your car finishes before the Bot will be recorded as a valid and timed, all other lap times will be marked as DNF. During head-to-head all laps will start from the starting line, running start laps won't be allowed. A lap will be considered complete when either you or the AWS Bot Car crosses the finish line.
- b. For head-to-head race, if a crash happens and both cars cannot move, the pit crew will split them up at the current location. If crash happens but both cars can move, the race continues.
- j. If the race timer has run out and no valid lap has been completed, you will not have a valid lap time to submit and be marked as DNF. Your DNF attempt will not be listed on the leaderboard.
- k. If all four wheels of the car is on the field (green surface and considered off the track), an AWS employee will use their reasonable best efforts while acting in a safe and controlled manner to reset the device at the last good point on the track, that is, the last point where it touched the track or borders.
- l. If your car starts driving in the wrong direction during the race, an AWS employee will use their reasonable best efforts while acting in a safe and controlled manner to reset the device at the last good point on the track. Racers are required to stop vehicle if driving in the wrong direction.
- m. Once the first lap of an attempt has been initiated, the race attempt timer will not be paused or restarted due to operator or model malfunction. Attempts interrupted due to mechanical malfunction that are not the direct result of the operator or model causing mechanical damage to the device during an attempt shall be awarded at the sole discretion of the official AWS DeepRacer Track Boss.
- n. If the vehicle encounters an issue during an attempt, our track and pit bosses will use reasonable best efforts to troubleshoot and return the car to the starting line to continue, until the countdown timer has expired. If the pit crew is unable to remedy the issue before time runs out, that attempt will be considered completed and no additional time shall be granted.

**For Virtual Circuit Races:**

- a. You may only submit your own models or the sample models provided in the AWS DeepRacer service.
- b. You may submit your models to any and all of the virtual races in the AWS DeepRacer service while the races are open.
- c. Each virtual race will have a specific race setup e.g. the race track, the race type, ranking metric, number of laps, time penalties, and other parameters, which may change from race to race, and will be indicated in the race setup in the AWS console. The race types include time trial, object avoidance, and head-to-head. Races, unless otherwise indicated, will require that you complete 3 laps. During a race submission, if your car goes off track, that is all four wheels are outside the white border lines, or collides with a bot or another car, it will be reset onto the track. Resets will receive time penalties of 2 seconds for off-track resets, and 2 seconds for

collision resets. The ranking metric is the total time taken, unless otherwise indicated, to complete the required number of laps.

- d. The AWS DeepRacer service will automatically evaluate the performance of your model according to the race setup. Your model will be ranked according to its ranking metric (default will be total time taken to complete the required number of laps). If your model could not complete the indicated laps, or some other error occurred, your submission will receive a DNF, and will not be entered into the leaderboard.
- e. You can submit as many models to a Virtual Circuit race as you like and only the best submission, based on the ranking metric, time will be displayed on the leaderboard.
- f. Where the race type is a head-to-head race, the ultimate race winner will be determined by a final seeded bracket elimination once the race ends. The bracket will be determined by AWS. The top ranked 32 participants (or other number as indicated in the race) when the race closes will take part in an automated bracket elimination. Your best model from this race will be used in the bracket elimination. The last racer standing in this bracket elimination will be the official winner of the race. Racers that have won first place in prior races in the 2020 AWS DeepRacer League season, will not take part in the top 32 bracket elimination.
- g. Each bracket elimination race consists of a continuous lap race with a predetermined number of laps (3 unless indicated otherwise) and predetermined number of objects (3 unless indicated otherwise) on the track. Racers will receive time penalties for resets due to going off-track or crashing into an object, or causing a crash with the other racer. The racer who completes all laps first will win the race.
- h. The results will be published and made official on the 6<sup>th</sup> good US business day after the race closes on [www.deepracerleague.com](http://www.deepracerleague.com) and in the virtual race leaderboard.

In the Virtual Circuit and Summit Circuit, where racers have raced in multiple races in the same event, monthly race, for Virtual Circuit or AWS Summit for Summit Circuit, the Head-to-head race winner will be determined before the Object Avoidance race winner (if applicable) and the Time Trial race winner, and the Object Avoidance race winner will be determined before the Time Trial winner. In all cases, in the event that two or more entrants have exactly the same lap time during a Summit Circuit race, or in a Virtual Circuit race, the winner will be the entrant that achieved their lap time first as determined by the time they raced during the Summit Circuit race, or submitted their model to the Virtual Circuit race.

For Summit Online Event Races, there is no elimination bracket or Head-to-Head tournament at the end of each applicable Summit Online Event Race period, as outlined at [www.awsdeepracerleague.com](http://www.awsdeepracerleague.com) (the "Summit Online Event Race Period"). The winners of Summit Online Races are determined by the leaderboard times at the end of the applicable Summit Online Event Race Period. Otherwise, the rules for the Virtual Circuit will apply to the Summit Online Event Races, unless otherwise specified at [www.awsdeepracerleague.com](http://www.awsdeepracerleague.com).

## 5. PRIZES:

- A. **First Prizes (98 total, 74 from Summit Events, 24 from Virtual Events):** Each first prize is a trip to re:Invent 2020 in Las Vegas, NV USA ("First Prize"). Each First Prize includes round-trip coach / economy class air transportation from winner's nearest international airport to Las Vegas, NV USA, for winner only (except as otherwise set forth in this section), five (5) nights standard hotel accommodations (single room/double occupancy), ground transportation to/from airport and hotel, \$350 USD total for meals and expenses, 1 ticket to re:Invent 2020, and the opportunity to participate in the Championship Event Race. If a winner is a resident of Hong Kong or the United Arab Emirates, the 350 USD allowance for food and travel will be provided via a pre-paid credit card. If winner is a minor in his/her place of residence, winner must be accompanied by a parent or legal guardian. Travel will be provided to the minor winner's parent or legal guardian by the Sponsor on the same basis as for the winner. Trip must be taken on dates specified by Sponsor. If applicable, winner and parent/legal guardian must travel on the same itinerary. If a winner resides within a 100-mile radius of destination, ground transportation may be

provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. All First Prizes and elements of First Prizes (including airline tickets, hotel accommodation, and any pre-paid cards) are non-refundable and non-transferable. Each winner and parent/legal guardian (if applicable) are responsible for having valid travel documents including visas, government identification and/or passports. Winners are responsible for all travel expenses not included herein, including but not limited to airline baggage fees, gratuities, meals, and any other incidental costs or expenses related to participation in this prize. If applicable, parent/legal guardian of minor winners must sign and return a travel liability release before travel will be booked. Each winner and his or her parent/legal guardian (if applicable) hereby acknowledges that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of the trip. Each winner, and/or his/her parent/legal guardian, will be required to provide a major credit card upon hotel check-in, and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of the winner. The Contest Entities bear no responsibility if any event, element or detail of a prize is canceled, postponed or becomes unavailable for any reason and Sponsor will promptly notify the affected winner of any cancellation, postponement, or unavailability. Should any event, element or detail of the prize become unavailable, the Contest Entities shall have no obligation to the winner aside from providing the remaining portion of the prize, minus any unavailable event, element or detail. The approximate retail value ("ARV") of each First Prize is: \$4,000.00 USD. There will be ninety-eight (98) First Prizes available in this Contest.

**B. Second Prizes (490 total, 370 from Summit Events, 120 from Virtual Events):** The winner of each First Prize will also receive a Second Prize as set forth below.

- a. Summit Event Second Prize: Each Summit Event second prize is an AWS DeepRacer car ("Summit Event Second Prize"). The ARV of each Summit Event Second Prize is \$399.99 USD. Only 1 Summit Event Second Prize can be won per person. In the event an entrant has already won a Summit Event Second Prize, it will be awarded to the next highest placing eligible entrant who has not already won. In the event that Sponsor/Administrator is unable to deliver the Summit Event Second Prize to a potential winner, the winner may receive \$399.99 USD awarded via the Sponsor/Administrator's preferred payment method. See Section 6 below for more information.
- b. Virtual Event Second Prize: Each Virtual Event second prize is \$399.99 USD awarded via the Sponsor/Administrator's preferred payment method ("Virtual Event Second Prize"). Limit: 1 Virtual Event Second Prize per person.

For Summit Online Event Races, the number of First and Second Prizes may differ per each Summit Online Race, as outlined at [www.awsdeepracerleague.com](http://www.awsdeepracerleague.com).

**C. Prize Conditions:** If a potential prize winner is NOT a legal resident of one of the following countries or regions; the United States, Canada (excluding Quebec), Argentina, Australia, China, France, the Federal Republic of Germany, Hong Kong, India, Ireland, Israel, Italy, Japan, Mexico, Netherlands, Poland, Singapore, South Africa, South Korea, Spain, Sweden, Switzerland, Taiwan, United Arab Emirates, or the United Kingdom, his/her ability to claim and receive a prize will be subject to local laws and restrictions of his/her place of residence. As a result of any local laws and restrictions, potential prize winner

may not be eligible to receive a prize and prize will therefore be forfeited. In the event a prize is forfeited for any reason, including for non-compliance with these Official Rules, no additional prize will be awarded. Prizes will not be redeemed or exchanged for cash, except where required by law. In no event will more than the stated number of prizes be awarded. No prize substitution or exchange will be allowed, except by the Contest Entities, who reserves the right to substitute a prize of equal or greater value in case of unavailability of the prize.

- 6. HOW TO CLAIM A PRIZE:** At the conclusion of each Summit Event race, the potential winners will be directed by an AWS representative to complete an online prize redemption process. **All on-site Summit Event race winners must claim his/her Summit Event Second Prize and complete the online prize redemption process at the Summit Event. If a potential on-site Summit Event Second Prize winner does not claim his/her AWS DeepRacer Car at the applicable Summit Event, he/she will automatically receive the cash equivalent prize and will no longer be eligible to receive the AWS DeepRacer car.** If an affected winner is a resident of Hong Kong or the United Arab Emirates, cash equivalent will be provided via a pre-paid credit card. All information and required documentation must be completed and submitted in the prize redemption portal. Virtual Event and Summit Online Event race winners will be notified via e-mail using the information disclosed at the time of registration and provided further details to claim his/her prize. Before being declared a verified winner, the potential First Prize winners, or in the case of minors, their parents or legal guardians, must complete, sign, and submit an Affidavit of Eligibility/Liability & Publicity Release and a tax acknowledgement form ("Affidavit"), within fourteen (14) business days from the date it is e-mailed to the potential winner by the Administrator. Potential winners are subject to verification of eligibility and compliance with these Official Rules and/or applicable law. Failure to provide all required information and complete all of the other required activities within the stated time period may result in forfeiture of winner's right to claim a prize, and may result in the prize being awarded to an alternate winner, if time permits. If permitted, the potential winners may be subject to a background check before the prize is awarded. Sponsor reserves the right to disqualify the potential winner based on the results of such background check if Sponsor determines in its sole discretion that awarding the prize to any such individual might reflect negatively on the Sponsor. Further, winners are responsible for their behavior whilst taking the prize. The Sponsor reserves the right in its absolute discretion to exclude a winner from participation in any aspect of the prize if the winner fails to comply with the directions of the Sponsor or any companies associated with the prize or if a winner acts in a manner that is dangerous to themselves or to the public or is, in the opinion of the Sponsor, anti-social, infringing, or disparaging in any manner or which causes a disturbance or nuisance to others. Upon verification of eligibility, the winner will be contacted regarding prize fulfillment and Sponsor/Administrator will coordinate travel arrangements, if applicable. If a potential winner is found to be ineligible, declines to accept the prize, or any winner notification is returned as undeliverable; the potential winner cannot travel on the specified dates; the potential winner fails to respond to a winner notification within the timeframe specified in such winner notification; or if a potential winner does not answer the initial notification, the prize may be forfeited. If a prize is unclaimed, unredeemed or any portion thereof returned as undeliverable, it will be forfeited. Un-awarded prizes will remain the property of the Sponsor. Prizes are not transferable and includes only the items specifically listed as part of the prize. Approximate retail value is as of the time these Official Rules were printed and the value of the prize may fluctuate based on winner location and cost of travel. The winners are not entitled to any difference between the ARV and the actual value of the prize at the time the

prize is awarded. If, after a good-faith attempt, Sponsor/Administrator is unable to award or deliver a prize, that prize will not be re-awarded.

EACH WINNER WILL BE ISSUED A FORM 1099 FOR TAX PURPOSES, OR EQUIVALENT TAX FORM IN HIS/HER COUNTRY OR REGION, IF ANY, IN THE AMOUNT OF THE ACTUAL RETAIL VALUE OF THE PRIZE AND MUST SUBMIT HIS/HER SOCIAL SECURITY NUMBER, AS AND IF REQUIRED BY LAW.

Each winner shall be solely responsible for payment of any and all applicable federal, state, provincial and local taxes for the prize won. Where applicable, the Sponsor may require winners to provide additional tax information, as required by law.

- 7. LIMITATION OF LIABILITY:** By participating in this Contest, entrants agree that the Contest Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents (“Released Parties”) are, to the extent permitted by law, not responsible for: (i) lost, late, incomplete, stolen, misdirected, undeliverable e-mail notifications, or postal mail; (ii) any computer, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/Internet/website/UseNet accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Contest; (vii) any injury or damage, whether personal or property (including any injury related to participating in a race), to entrants or to any person's computer related to or resulting from participating in the Contest and/or accepting or using a prize, except for any liability which cannot be excluded by law; (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, or otherwise not in compliance with the Official Rules; and (ix) for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense or damage which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Contest or accepting or using a prize, except for any liability which cannot be excluded by law.
